<b>Promoter</b>	The Promoter is Hartman Group (ABN 67 069 587 695) of 1 Federation Way, Moorabbin Airport, Vic, 3194.
<b>Promotion Type</b>	Game of Chance
<b>Promotion Period</b>	The Promotion will commence at 12.00am AEST on the 10 <sup>th</sup> May 2021 and close at 11.59pm AEST on 30 June 2021
<b>Entry restrictions</b>	<p>This promotion is only open to residents of Australia aged 18 years and over for purchases made in Australia. Employees (and their Immediate Families) of the Promoter, of Participating Stores or any of their respective parent companies, subsidiaries or affiliated companies, or any agencies associated with this promotion are ineligible to enter. “Immediate Family” means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child, parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or first cousin and the persons referred to above includes natural and non-natural relations (in the opinion of the Promoter).
